- 3. To select all available states, click on the second arrow button to immediately move all available states to the Managed States list.

#### To remove a state or jurisdiction:

- 2. To select multiple states, hold down the "Cntrl" key while selecting them.
- 3. To clear the Managed States list, click on the bottom arrow button to immediately move all selected states back to the Available States list.

## Searching for a Single Producer

To search for a producer using this window, please complete the following steps:

- Individual Search: To search for an individual person, enter their biographic information into the Individual Search fields.
  - If searching by SSN, a Last Name is also required.
  - If searching by First Name and/or Middle Name, a Last Name is required.
- Business Search: To search for a business, enter their FEIN, Name, and/or NPN into the Business Search fields.
- License Search: To search using an existing license, enter the License ID, License State, and License Type into the License Search fields.
  - The License ID and License State are required fields. The License Type is optional.

If your search is a success, the window will display the individual or business that matches your provided information.

## Adding a Producer

To add the producer returned by your search to the Select Producers page, click the "Add Selected Producers" button, and then click the "Close Search" link to return to the Select Producers page.

## **Multi-Producer Search**

This pop-up is used to search for a single producer to add to the Select Producers page. To access it, click the "Search for Producers" link located on the Select Producers page, and then click on the "Multi-Producer Search" tab.

#### **Searching for Multiple Producers**

To search for producers using this window, please complete the following steps:

- 1. Select the desired criteria type you wish to use, such as SSN and Last Name, or FEIN.
- 2. Enter the search criteria in the Data Input box.
  - 1. To enter multiple items, enter them line by line (that is, enter the first item, press return, enter the second item, etc.). Putting multiple items on the same line, or using punctuation (for example, "123, ABC"), will result in an error.
  - 2. If desired, you can upload a document containing your data by clicking on the "Upload a file" link you will be prompted to search for and add the desired file.
    - The file you upload must be saved as a .csv or .txt file.
    - Headers can be added to the file.
- 3. Click the "Search" button to execute your search.

## Viewing Results

On the results page, your results are organized into the following tabs:

- Found on PDB: Producers that match your search criteria and exist in the PDB are returned here. You can select these producers to be added to this workflow.
- Not Found: This tab lists the search data that were not found in the PDB. For example, if NPN "1234567" doesn't exist in the PDB, it would appear here.
- Invalid: This tab lists any search data that was not recognized by the system. For example, entering "123, ABC" as an NPN will result in the system returning this as an invalid search value.

Only the results on the "Found on the PDB" list can be added to your workflow.

## **Adding Producers**

To add producers from the "Found on PDB" list, check the checkbox for each producer you wish to add, and then click the "Add Selected

Producers" button.

Click the "Close Search" link to return to the Select Producers page.

## **Select Lines**

This page is used to select the lines you wish to appoint or terminate for the selected producers. If multiple states were selected, these selections are done by state.

## **Selecting Lines for Appointment or Termination**

To select a line, please complete the following steps:

- 1. Mark the checkbox associated with the relevant producer and line to include that appointment or termination in your workflow.
- 2. Select or edit (if allowed) the Effective Date for each selected line. Please note that, dependent on state rules, the Effective Date may be limited to the current day, or to a certain range of dates.
- 3. When you have finished your selections, click the "Next Step" button to continue to the Review page.

As stated, if multiple states are involved, you will need to use the state tabs to navigate to each state and make the relevant selections for that state. The checkboxes in the column headers can be used to select or de-select all eligible producers for that line.

Clicking the "Back" button will return you to the Select States and Jurisdictions screen.

**Please Note**: If you have multiple workflows in the system, the application will prevent duplicates by not allowing you to add a line to this workflow if that selection already exists in your cart. For example, in the screenshot above, the user is unable to select the Casualty line for this producer because this selection is in an existing workflow already in his or her cart.

From here, you can select to remove one or more selected items, or return to the previous screens to edit your work. Clicking the "Back" button will return you to the Select Lines screen.

#### **Remove Items**

To remove a producer, mark their checkbox and then click the "Remove Selected Items" link. The system will remove the selected item or items and update your workflow accordingly.

## **Proceed to Checkout**

When you are satisfied with your workflow, you can proceed to the checkout page by clicking the "Next" button. Be aware that once you do so, this workflow will be added to your cart, and individual items can no longer be edited (although they can still be deleted, as can the overall workflow itself as well).

Any edits, such as changing the selected lines or adding a producer, that need to be made after adding a workflow to the cart will require deleting the existing workflow and starting over with a new one.

# Checkout

From this page, the following actions can be performed:

- **Deleting Items**: To delete an item from your cart, mark the checkbox next to it and click the "Delete Selected Items" link. The system will remove the selected item or items, and update your fee summary.
- Save Selected Items: To save an item, which will keep it in your cart but not include it in the current checkout process, mark the checkbox next to it and click the "Save Selected Items for Later" link.
